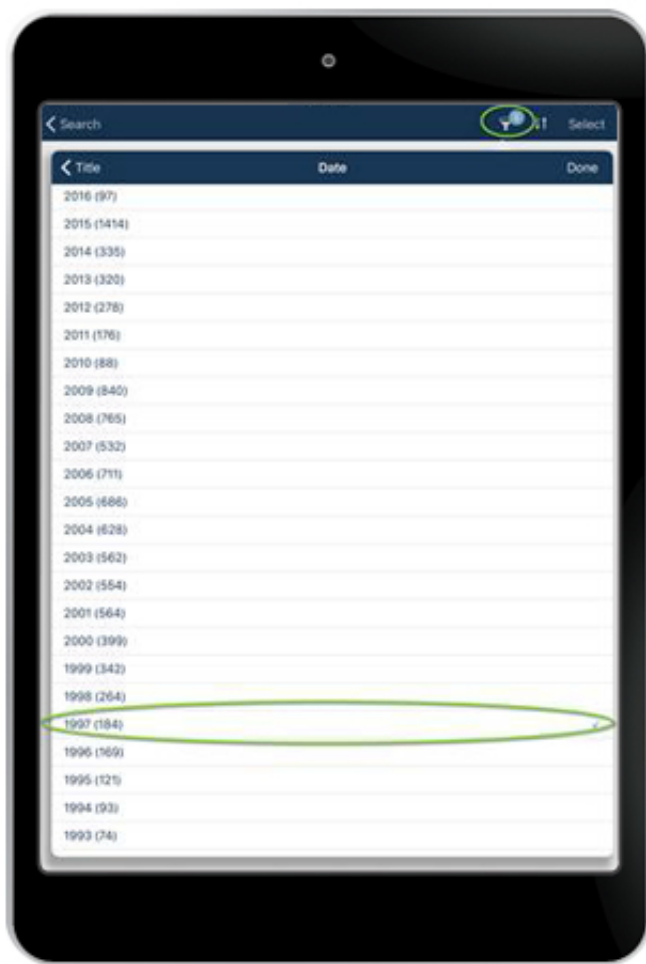

Need a title on the go? Use our app to find it! Our app features the same robust search capabilities as the web version of Discover PLUS, including filters to refine your results quickly and easily. We include our complete Course Handbook library – even the archival titles.

For example, if you are looking for tax materials from 1997, you can select "Tax" from one of the practice areas and then use the date filter to home in on the year 1997. Download any books or chapters you want to review and you will be able to access them even when you're offline. Any notes, highlights or bookmarks you make will sync up to help you stay on top of your work and research when traveling or on the go.
